

POWERLESSNESS – Part 2.

These people died precisely because YOU have allowed that the conviction created by fear was put in your collective consciousness. Such convictions are created by fear in such a way, once put in the collective consciousness, they can then take away the LIGHT OF FAITH, even if you have it on my palm right in front of you.

And this is because the powerlessness that you create in you will not allow you to move at all, and YOU cannot stretch your hand to take the Light of Faith and put it back in your heart.

And besides this helplessness, fear in these beings has created a great sense of injustice to life itself, with the question of „why me,, „why my son or daughter,, „why my beloved one,, „why my parents,, and in this way, it created immense pain in you, not only in those human beings who have had leprosy, but also in those who they love and those who loved them.

And it is through this pain that fear has anchored itself in human society, it has completely taken control over it with its power, because it has achieved that, as human beings, you were so worried about your life that all human society had no compassion for those who became ill. You did not provide any help for them.

On the contrary. Society has excluded them and was very cruel to them.

And thus fear achieved that cruelty was anchored in human society.

And once you allow cruelty to anchor and become part of human society, it takes a very long time before you can dissolve it and transform it into Love.

And fear succeeds to do so when the conviction, it creates within you becomes part of your human collective consciousness.

And this does not apply just on leprosy disease as such, but it is equally true with any disease that you believe to be deadly, and equally true with every war conflict that has occurred on Mother Earth throughout human history.

And so you can see for yourself how much cruelty is still in your society.

And now I will return to the conviction that fear creates in you in this way.

You can change and dissolve it only if each one of you does it for yourself on your own, because then it is transferred from within to your society and then transcribed in your collective consciousness, and that's why you are able to cure leprosy today.

It is the same as when, at the time of the Inquisition, the Church tortured, burned and killed innocent people just because they were healing others.

Oftentimes, due to fear, envy, misunderstanding and prejudice, these people have been accused of witchcraft. It has stopped when you understood that they are not witches and have nothing to do with the devil. They only used the healing power of herbs and plants to cure other people, and so they put their knowledge and experience in use for the benefit of others and the whole society.

And then you stopped being afraid of these human beings and therefore it could be rewritten in the human collective consciousness.

It takes so long, unimaginably long, from the perspective of the life of human being, because this change must take place within you in each one of you, in every human being.

And the pain that has arisen in the heart of those human beings who have had leprosy and who have been cruelly excluded from human society, who were left alone without any help, is the equally as the non-acceptance of the situation that the human being subsequently created in himself.

I will explain this to you as an example of one of the possible situations that many of you have experienced in the line of time of your being on Mother Earth. The circumstances, under which you have experienced it, may vary.

Imagine a young man, healthy, strong in the burst of life, who has many plans in his head, all life ahead of him, and who loves the woman of his heart very much and she loves him back.

Precisely because she loves him too, he becomes uncomfortable, feared and unwanted rival of another much older man whose she was supposed to marry, while not loving this woman at all. He just wanted to unite and merge family wealth and thus increase his power.

And as this woman refuses to obey her parents' decision and refuses to marry a much older man, the young lover whom she loves, must be removed so that they can unite and merge family wealth and increase the power.

The plan, of that older man to get to the property he craves so much and to get rid of this young man, is very simple and unimaginably cruel at the same time because he accuses him of having leprosy.

And he creates an opportunity to accuse him of leprosy in front of a large number of people. The fear of these people will give the young man no chance to defend himself, and they will condemn him to death due to the fear of their own death.

And at the time when the rival accuses the young man of having this disease - leprosy, the young man does not suffer on leprosy at all and is completely healthy, but since the fear of those human beings gives him no chance or opportunity to prove them wrong, they simply take him out of town to the place where are all people who suffer from leprosy.

And since no one can leave this place alive, they practically condemned the young man to death.

The young man will not understand, nor will he accept this situation in his life.

The way, the older man got rid of the young man, was very cruel. The greedy, much older man achieved what he wanted for himself, possessions, power, but also the woman the young man loved so much.

The young man was blinded by his love, by his fearlessness and by his the great physical strength, and so he could not see that much older man did not have to use physical strength to defeat him in his face-to-face combat. Instead of this, it is enough for him just to use greed, fraud and bribery to get rid of him so he could achieve what he wanted for himself in his life, namely property and more power at any cost, even for the sake of life. The young man relied too much on his youth, his strength, and the Love of the woman he loved and he thought to be untouchable. At the same time, he was self-centred, and it was this pride of youth that blinded him and thus he could not see the strengths of his rival because he created a conviction in himself that the rival was a weak, old, helpless old man and that he would easily beat him in a man-to-man duel.

And then he did not accept this situation, which occurred and took it as an enormous injustice of life, fate and injustice of God, with remorse: „why me,, !!!

And when he accused him, he did not defend himself, for he did not see through that it was set up trap, deceit and lie, and that what he was accused of might not be true.

He found out the truth, only when he got to the leprosy camp where people with leprosy stayed, they told him that he had nothing on his body and that he was not sick, but they could not let him out of there anymore and they did not want to. Only then the young man understood that he had been deceived and removed. He became very angry with himself that he let it happen and that he had not seen the scam, but at the same time, he did not see that he was basically angry with himself. He projected his anger and put all blame on his rival thus he only increased his own powerlessness. This all fueled his belief that he would not come alive from the leprosy camp and so he lost the Light of His Faith and indeed then he died on leprosy.

And if the young man could keep the Light of his Faith, he would survive.
